GENERAL TERMS & CONDITIONS

1 The booking is final & *confirmed* from the moment the customer has paid his down payment of 30 % from the total invoice and charter agreement invoice.

The “SALDO / rest payment” :

- of the Yacht itself is due 1 week before departure
- of the OPTIONS is due 30 days before departure.

2 All other obligations will be paid before departure:

- tourist tax & cleaning
- warranty
- open non paid extra OPTIONS.

3 Children under 9 year are traveling at responsibility of their parents.

They must be insured by the parents themselves ! The Skipper neither the owner of the yacht can be put in responsibility in anyway for children less than 9 years old.

4 If the weather circumstances are so bad that the Skipper decides not to leave the marina, or

If due technical problems the charter cant proceed,

- has the customer in consultation with the owner, the right to choose another day/period to charter the yacht without any supplementary costs to be paid

If due to circumstances of the customer himself, the charter cant proceed, the customer has no right to choose another day/period for chartering and the SALDO/rest amount of all payments will be due.

In anyway, the customer has no right to claim any money restitution under any circumstances.

5 The Yacht is always chartered WITH SKIPPER. However:

IF the lessee has a valid boating license, there is the possibility to cancel the skipper but

- ⇒ there will be obligatory a BOATSMAN on board (roping) as a control and guide and as a help there were it will be necessary.

In the case the Skipper is the lessee himself, there will be a *cash* warranty of 3.500 € in stead of 1.000 € and

- ⇒ the boatsman will be calculated at (-50%) = 125 €/day instead of the Home Skipper at 250 €/day. However,
- ⇒ the “active” SKIPPER is and remains *always* responsible for damage or whatever else during the renting period.
